Joint Message from CEO & Board Chair





Collaboration is a key ingredient of a successful clinical trial. A single study can bring together patients and families, health charities, philanthropists, industry sponsors, government funders, ethics reviewers, researchers, coordinators, healthcare providers and many more. All of these groups are working together towards a common goal: developing new treatments for people who desperately need them.

Since the beginning, collaboration has been the cornerstone of our work at Clinical Trials Ontario. Our role has been listening the needs of the clinical trials community

and partnering to find new ways of reaching that common goal more quickly and effectively. With ongoing engagement and dedication from the community, we have taken bold steps to deliver on our mandate of improving the environment for clinical trials, engaging patients and the public and compelling industry to choose Ontario for their next opportunity.

CTO Stream, our flagship program that allows a single ethics review for multi-site clinical trials, has cemented its place in Ontario's clinical trials ecosystem and it continues to grow. This visionary program was built by the clinical trials community, including highly

qualified and committed Research Ethics Boards, and was officially launched in 2015 to make trials faster, less resource-intensive and more efficient. Today, the program supports nearly 1,000 research studies, with participation from 20 CTO-Qualified REBs, 104 trials sites and more than 90 pharmaceutical and medical device companies.

Building on this momentum, institutions and industry sponsors worked with CTO to launch the QuickSTART program this year. QuickSTART enables clinical trial sites and industry sponsors to achieve trial activation within just 90 days by setting targets

and establishing standardized processes. Three engagements were successfully completed in QuickSTART earlier this fall, and we are thrilled to see more studies engaging with this community-built program. We also brought together representatives of more than 80 Ontario-based clinical trials sites with our new Trial Site Network, enabling CTO to provide industry with warm introductions to interested hospitals and research institutions.

Working in lockstep with patient groups and health charities, we're making it easier for patients and the public to engage with clinical trials by co-developing new tools and resources. Our new Clinical Trial Finder, launched this spring, is the only resource of its kind in Canada that uses plain language and allows people to search for active Canadian trials by location, disease and demographic. This year, we also published new online education modules and decision aids that walk people through the decision process of participating in a clinical trial or joining a clinical trial team.

All of this success is owed to our

community's shared vision of a stronger clinical trials environment and, ultimately, more opportunities for Ontarians to access new treatments and technologies that will improve their daily life. Because that's what it's all about: better health for Ontarians and for the future.

As we celebrate our shared achievements in this report, we would like to thank the Government of Ontario for its recognition of vital role that clinical trials play in this province and for its continued support of our community's work. We also thank our dedicated team, our Board of directors, and the members of our clinical trials community who are tireless in their efforts to discover the treatments of tomorrow, today.

A landmark clinical trial at UHN, which proved that fibrinogen concentrate is effective and beneficial to patient welfare, has created a safer blood supply system in Canada.



The Ottawa Hospital developed an approach for experimental CAR-T cancer treatment, and is leading the way nationally in testing it in a clinical trial.



A multi-centre registry trial, led by researchers at Lawson Health Research Institute, is testing the use of a new imaging tracer for early detection of recurrent prostate cancer. The Trial will give 1,500 Ontario patients access to a new type of imaging and will assess the impact on patient care.

Increasing **Investment in Ontario Clinical Trials**

Ontario has seen a nearly \$100 million increase in biopharma investment, from \$322 million in 2013 to \$410 million in 2017. Ontario has also established itself as **Canada's top destination** for clinical trials, with more than half of Canada's clinical trials conducted here.

With clinical trials playing such a pivotal role in our health care system and our health and life sciences economy, Ontario has an opportunity to grow the clinical trials industry. CTO was established by a cross-sectoral group of leaders in 2012 to do just that, and with ongoing engagement and input from our community, we have helped to increase investment in Ontario clinical trials.

Our collective impact is the result the clinical trials community's hard work to continue streamlining clinical trials processes, engaging with more patients and members of the public to improve trial conduct, and promoting our province's advantages and assets to attract more clinical trials to Ontario.

Fusion Pharmaceuticals, a Hamiltonbased clinical-stage biopharmaceutical company, raised \$105 Million in Series B financing for the development of targeted alpha-particle radiotherapeutics for treating cancer.



Synaptive Medical Inc., a Toronto-medical device and technology company, and **Sunnybrook Health Sciences Centre** created a partnership to foster safer outcomes for Canadians with Imageguided Therapy Technologies that led to an investment of up to \$49 million from Canada's Ministry of Innovation, Science and Economic Development.

Facilitating faster, more effective clinical trials



CTO Stream

Launched in 2015, CTO Stream is one of the largest collaborations in Ontario's health research sector, built by researchers, research ethics boards and industry leaders. Since then, it has become essential for conducting high-quality, efficient multi-site clinical trials in Ontario. The innovative online system enables all research sites participating in a clinical trial

to undergo a single ethics review rather than separately applying to their local research ethics boards, reducing the time and labour required to obtain research ethics approval. By driving efficiency and reducing red tape, CTO Stream has provided more than \$5 million in estimated cost savings to the public system.

CTO Stream is now an essential part of Ontario's clinical trials ecosystem. To better support our growing number of users, CTO Stream will be introducing an online Helpdesk and ticketing system in late 2019.



QuickSTART

A typical clinical trial can take more than five months to get started, which drains time, resources and energy for research institutions and industry sponsors. QuickSTART, a program developed by Clinical Trials Ontario (CTO), is significantly speeding up this process. Launched as a pilot in early 2019, QuickSTART enables clinical trials sites and industry sponsors to develop authentic partnerships, set targets and enhance existing procedures without disrupting them, all to improve efficiency and achieve activation within just 90 days.



Key Pilot Outcomes

1

Shared interface creates transparency and enables authentic partnerships between industry and institutions

Dynamic and flexible platform does not disrupt internal procedures, but enables a more streamlined approach to setting milestones and meeting timelines

Setting transparent targets, responsibilities and mutual agreement at the outset gives participants license and support to move the process forward

Improving Patient & Public Engagement with Clinical Trials

CTO is committed to developing ways to better engage patients and the public with clinical trials. We work closely with health charities and patient organizations to understand their needs and the needs of their communities. Everything we do to promote patient and public engagement in clinical trials is driven by their input. Together, we are raising public awareness of clinical trials, creating new resources to learn and access clinical trials, and supporting researchers and healthcare providers in their interactions with patients around clinical trials.

Clinical Trial Finder app designed by patients, for patients



This year СТО launched the Clinical Trial Finder, a new online search tool

that helps Canadians look for active clinical trials using a range of criteria, including condition, location and demographics. The tool was co-developed with guidance and input from CTO's community of patient organizations and health charities, and is the first plainlanguage trial finder tool of its kind in Canada.

Since its launch in the spring of 2019, the tool has had nearly 2.000 visits and more of our health charity and patient organization partners are placing the Trial Finder widget on their websites.

New engagement tools for patients and providers

In addition to the Clinical Trial Finder, CTO has created new patient- and public-friendly online resources, including information to walk an individual through the process of participating in a clinical trial and decision aids for patients and investigators considering patient engagement on research teams. Like the **Clinical Trial Finder, these tools** were co-developed with input from health charities and patient organizations. In Fall 2019, all of CTO's online patient and public resources will be translated into French, expanding their value to all Canadians.




Bringing voices together

Industry Concierge & Trial Site Network

CTO's Industry Concierge service continues to help connect industry sponsors into Ontario's clinical trials ecosystem. This vear, we established a new Trial Site Network which enables industry to connect directly with Ontario's agile, efficient and high performing trial sites. The Network is comprised of highly engaged research personnel representing more than 80 research institutions. hospitals and trial sites across the province. With this new service, CTO can provide any company or start-up looking to conduct a clinical or observational study in Ontario with a warm introduction to

Promoting Ontario at BIO 2019

CTO showcased the Ontario-Quebec clinical trials corridor at the 2019 BIO International Convention in Philadelphia on June 3, 2019. We co-hosted a session on Rare Disease and Genomics, in partnership with Ontario Genomics. Montreal InVivo and Genome Quebec, and in collaboration with Biogen, Pfizer Canada and Takeda. More than 170 representatives from multi-national pharmaceutical companies, biotech companies,

contract research organizations. academia and the Ontario and Quebec governments attended the session which discussed the exciting impact of genomics on the development of individualized therapies. BIO 2019 attracted more than 16.000 biotechnology and pharma leaders from across 67 countries.

Supporting start-ups in Ontario's clinical trials community

CTO co-hosted a sold-out event during Toronto Health Innovation Week on April 5th, 2019 in partnership with local clinical ecosystem organizations including Women's College Hospital's Institute for Health System Solutions and Virtual Care (WIHV), St. Michael's Hospital's Applied Health Research Centre (AHRC), TOHealth! and University of Toronto's H2i. More than 50 clinician entrepreneurs, start-up

representatives and others learned about Ontario's clinical trials advantages and how CTO can help connect them into the ecosystem through our Industry Concierge service and other programs.

As one of the largest conferences of its kind in Canada, the CTO Conference is among Ontario's most important knowledge exchange and networking opportunities within our clinical trials ecosystem. On March 27th and 28th, 2019, the Clinical Trials Ontario conference brought together nearly 500 members of the clinical trials community, including leaders from the pharmaceutical and medical device industries, academic and healthcare leaders. representatives from patient groups, health charities, government, and research institutions from Canada and the US.

Hosting the annual conference is just one of the ways that CTO improves the climate for clinical trials in Ontario and attracts business to the province. Speakers at the 2019 conference discussed how we can improve clinical trials today while preparing the ground for an even stronger clinical trials environment in the future. Harnessing artificial intelligence, improving patient engagement, and streamlining clinical research were key topics at this year's CTO conference. We also introduced our first annual Innovation Showcase, which enabled Ontario-based health start-ups to connect with guests and generate partnerships.


