Fuelling a thriving clinical trials sector

Joint message from Susan Marlin, President & CEO, and Rafi Hofstein, Board Chair

Clinical Trials Ontario (CTO) was established with a goal of making trials more efficient, effective and accessible, and promoting Ontario as a leading location to conduct clinical trials. Today, CTO is an essential pillar in the clinical trial ecosystem, helping to fuel Ontario's thriving life sciences sector. We are dedicated to strengthening, promoting and capitalizing on Ontario's competitive advantages for conducting high-quality clinical trials.

CTO Stream, our flagship program that allows a single ethics review for multi-site clinical trials, has cemented its place in Ontario's clinical trials ecosystem and it continues to grow. This visionary program, built by the clinical trials community, plays a key role in making clinical trials more efficient and costeffective. Today, the program supports over 2,100 research studies, with participation from 19 CTO-Qualified REBs, 117 trials sites and more than 195 pharmaceutical and medical device companies, and has led to an estimated \$18 million in estimated cost savings to Ontario.

Improving on how we conduct trials and making them available sooner to Ontarians underpins all the work we do at CTO. Our QuickSTART program works to reduce trial start-up times, our Research Ready program helps ensure that Ontario research institution staff have the skills and knowledge to conduct effective and efficient clinical trials, and our Industry Concierge and Trial Site Network support industry in starting trials in Ontario. Working alongside patient groups and health charities, we are continually working to improve the clinical trial participant experience and make it easier for patients and the public to engage with clinical trials.

This year, building on the success of our programs, CTO has embarked on leading a new collaboration with institutions and industry in Ontario. The Ontario Leadership Table for Clinical Trials, established in the spring of 2023, is focusing on implementing strategies to bring clinical trial opportunities and new therapies to patients as quickly as possible. A key priority of this group is to shorten clinical trial activation times and reduce the effort required to execute the activation process. The work of this group will lead to more opportunities for Ontarians to access new treatments and technologies that will improve their daily life.

As we celebrate our shared achievements in this report, we would like to thank the Government of Ontario for its recognition of the vital role that clinical trials play in this province and for its continued support of our community's work. We also thank our dedicated team, our Board of directors, and the members of our clinical trials community who are tireless in their efforts to advance health research forward, faster for an even brighter future in this province.

Facilitating faster, more efficient clinical trials

CTO Stream enables research sites participating in a clinical trial to undergo a single ethics review rather than separately applying to their local research ethics boards, reducing the time and effort required to obtain research ethics approval. Today, CTO Stream is the gold standard for supporting efficient, high-quality multi-site studies and has become integral to Ontario's clinical trial ecosystem.

QuickSTART

A typical clinical trial can take more than five months to get started. Our QuickSTART program helps sites and sponsors achieve activation quicker by developing authentic partnerships, setting targets and enhancing existing procedures without disrupting them. The program uses a custom-built digital platform and focuses on streamlining trial activation processes, such as budgets and contracts, identified as common hurdles by industry and institutions.





Ontario Leadership Table for Clinical Trials

Led by Clinical Trials Ontario in collaboration with leading institutions and industry in Ontario, the Ontario Leadership Table for Clinical Trials, established in the spring of 2023, will focus on strategies to bring clinical trial opportunities and new therapies to patients as quickly as possible. A key priority is to transform the current QuickSTART program to significantly shorten clinical trial start-up times and reduce the effort required to execute the start-up process. The Ontario Leadership Table is comprised of executive leaders from the top 10 research-intensive hospitals in Ontario and world-leading pharmaceutical companies conducting clinical trials in Ontario.

Research Ready

Research teams across Ontario are on the front lines of making clinical trials happen. They help design studies, recruit and support participants, and ensure all requirements are met to deliver high-quality clinical trials. CTO's Research Ready program is strengthening Ontario's world class health research infrastructure by providing research teams with high-quality training, education and mentoring resources that are relevant to the evolving needs of the community.

Raising Awareness as a Community

CTO works closely with <u>health charities and patient</u> organizations to co-develop and distribute informative clinical trials resources to their communities and to raise awareness to improve patient and public engagement with clinical trials. We've done this together through surveys, blogs, webinars, Facebook Live events, and conference presentations. Annually we also celebrate International Clinical Trials Day together through shared content and messaging on various social media channels. We thank this community for its ongoing support.



CTO's Tools & Resources for Supporting Patient & Public Engagement

CTO's tools and resources are helpful and accessible for patients, the public and the research community. The <u>CTO Clinical Trials Finder</u>, the first web-based search tool of its kind in Canada that connects patients and the public with active clinical trials across Canada, has been used by over 30,000 site visitors. Our <u>online education</u> <u>modules</u> walk people through the process of what to expect when participating in a clinical trial so that they can make informed choices. And our <u>Participant Experience Toolkit</u>, developed by a multi-perspective group, includes resources, templates and videos to help researchers ensure trial participants feel valued and informed.

Since its launch in 2017, CTO's Industry Concierge service has been connecting industry sponsors with resources and research sites in Ontario's clinical trials ecosystem. In 2019, we formally established our Trial Site Network, which now includes more than 200 academic hospitals, community hospitals and private research networks across the province. The network has proven to be a win-win: companies and start-ups connect directly with potential partners, and sites expand their research activities.

Collaborated with Invest Ontario to <u>publish a blog</u> about Ontario's recipe for a thriving clinical trials environment.




CTO Conference

The CTO Conference is one of the most important knowledge exchange and networking opportunities in Canada's clinical trials ecosystem. The conference draws 400-500 people each year from all corners of the clinical trials community, including hospitals and universities, industry, research ethics boards, health charities, patient groups, government and more.

Speakers at the 2022 conference discussed the need for collaboration in clinical trials and advancing clinical trials across Canada. We heard from speakers on inclusiveness in clinical trials and the importance of conducting research in community hospitals. The evolution of patient engagement over the past decade and the impact of the pandemic on Research Ethics Boards were other key topics at this year's conference.
